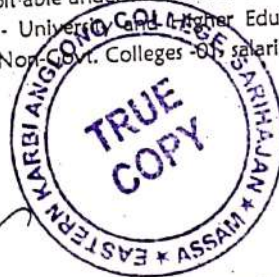
Terms and conditions:-
