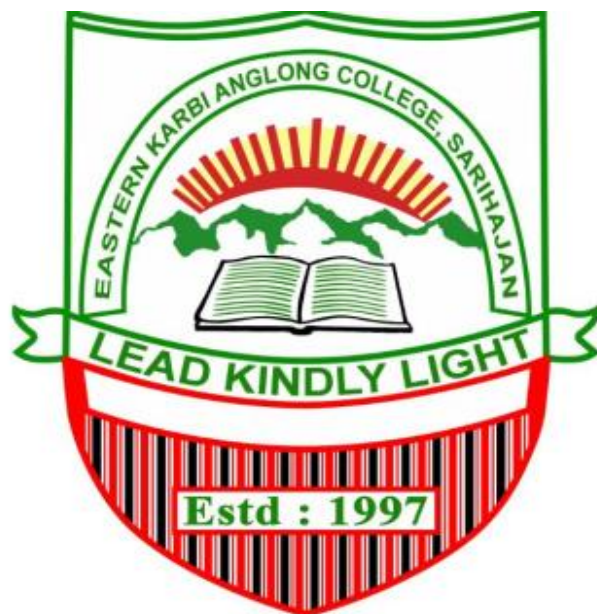


#### **Opinion:**

## **Auditor's Responsibilities for the Audit of the Financial Statements:**


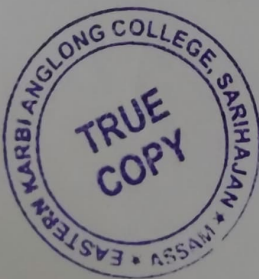
